<b>RECOMMENDED ACTION:</b> That the Board of County Commissioners approve an IGA with the Ricardo Flores Magon Academy for the Pedestrian Crossing Improvements on Lowell Boulevard south of W. 54th Avenue

### **BACKGROUND:**

Adams County and Ricardo Flores Magon Academy desire to enter into an intergovernmental agreement regarding improving the safety of school-aged children and the community by providing an enhanced pedestrian crossing of Lowell Boulevard south of W. 54th Avenue. Enhancements include decreasing the crossing distance via a hardscaped neck-down of Lowell Blvd, pedestrian push button activated and solar powered rectangular rapid flashing beacons, additional signage, and sidewalk connectivity and curb ramp improvements. The Ricardo Flores Magon Academy has agreed to reimburse the County for the work. The attached agreement and resolution have been reviewed by the County Attorney's office.
