RESOLUTION APPROVING ADAMS COUNTY AMERICAN RESCUE PLAN ACT  
AGREEMENTS FOR INTERNAL PUBLIC HEALTH AND NEGATIVE ECONOMIC IMPACTS  
PROJECTS

Resolution 2024 -

WHEREAS, on March 11, 2021, the American Rescue Plan Act (“ARPA”) was signed into law and established the Coronavirus State Fiscal Recovery Fund (“CSFRF”), and Coronavirus Local Fiscal Recovery Fund (“CLFRF”), collectively, the Coronavirus State and Local Fiscal Recovery Funds (“SLFRF”); and,

WHEREAS, ARPA provides resources to respond to the COVID-19 public health emergency, its economic impacts, and rebuild a stronger, more equitable economy as the country recovers; and,

WHEREAS, the County received an allocation of SLFRF from the United States Treasury to support recovery efforts including the ability to provide funding to subrecipients to spend on eligible expenditures under ARPA; and,

WHEREAS, within the eligible use categories outlined in the provisions of ARPA, the County has flexibility to determine how best to use payments from ARPA to meet the needs of the communities and populations provided the uses meet the objectives outlined in Section 603(c) of the Social Security Act as added by Section 9901 of ARPA (“SLFRF Objectives”); and,

WHEREAS, the Adams County Long-Term Recovery Team in collaboration with County Departments informs, proposes, and reviews projects utilizing SLFRF; and,

WHEREAS, the Adams County Long-Term Recovery Team and County Departments reviewed proposed projects and programs that focus on addressing Negative Economic Impacts for Adams County residents; and,

WHEREAS, on October 15, and October 22, 2024, the Adams County Long-Term Recovery Team in collaboration with County Departments recommended to the Board of County Commissioners the projects, referenced in Exhibit A, to be awarded Adams County SLFRF; and,

WHEREAS, the Board of County Commissioners supports the recommendations of Adams County Departments and the Long-Term Recovery Team and wishes to allocate funds to the internal projects listed in Exhibit A and,

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners, County of Adams, State of Colorado, that the recommended projects in Exhibit A be approved for Adams County American Rescue Plan Act funding contingent upon the official award and full execution of interagency agreements between, or contracts between County Departments.

BE IT FURTHER RESOLVED that the County Manager is authorized to execute said interagency agreements on behalf of Adams County upon approval by the Adams County Attorney’s Office.

BE IT FURTHER RESOLVED by the Board of County Commissioners, County of Adams, State of Colorado, that the County Manager or his designee is authorized to execute amendments to the American

Rescue Plan Act project agreements on behalf of Adams County, upon approval of the amendment by the Recovery & Major Initiatives Administrator and the Adams County Attorney's Office.
