BACKGROUND:

Adams County (County) owns a portion of the building located at 7190 Colorado Boulevard in Commerce City known as South Platte Crossing (SPC). Early Childhood Partnership of Adams County (ECPAC) works to enhance the welfare of residents in Commerce City and surrounding areas within Adams County through its community stakeholders to sustain a system of equitable access for child and family services. ECPAC's services include early childhood education, health, mental health, and familial support for children up to the third grade primarily for care navigation and parenting. ECPAC has leased office space at SPC since July 2021 and wishes to extend the lease term, pursuant to Section 2 of the Lease Agreement. The County wishes to extend the lease agreement with ECPAC through August 31, 2025.
